



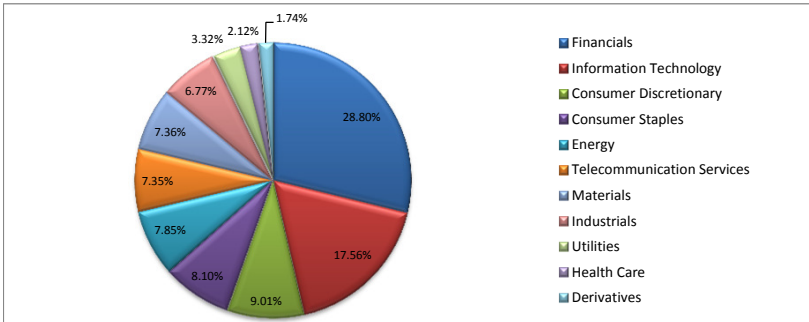

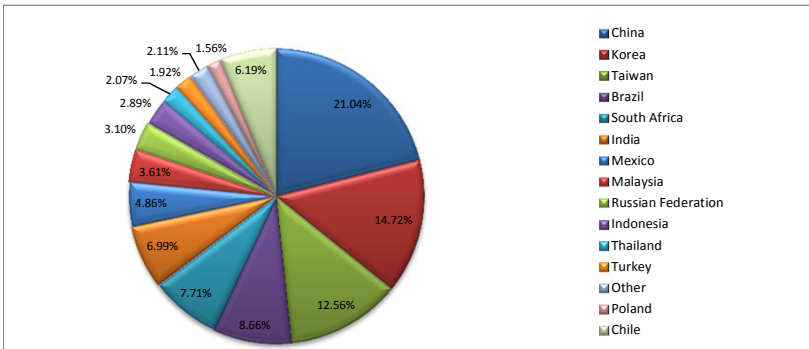
### Product Description

The Index seeks to provide a return on investment that tracks, as consistently as possible, international equity markets, as measured by the MSCI Emerging Markets index.

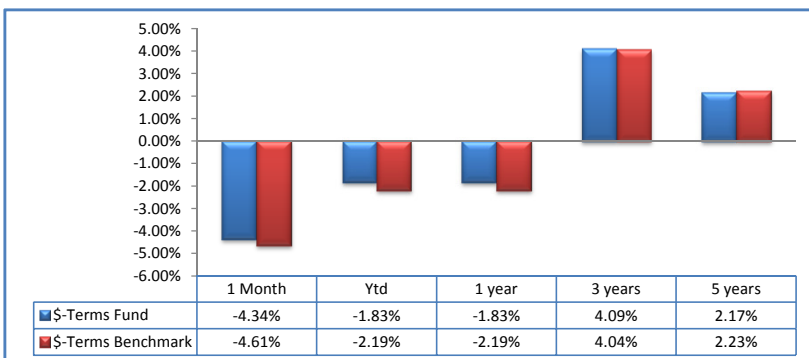
### Sector Allocation

Forward pricing is used and funds are valued on a daily basis by no later than 17h00.
