



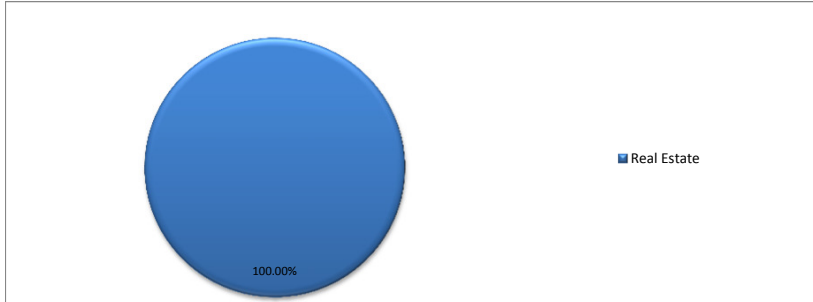

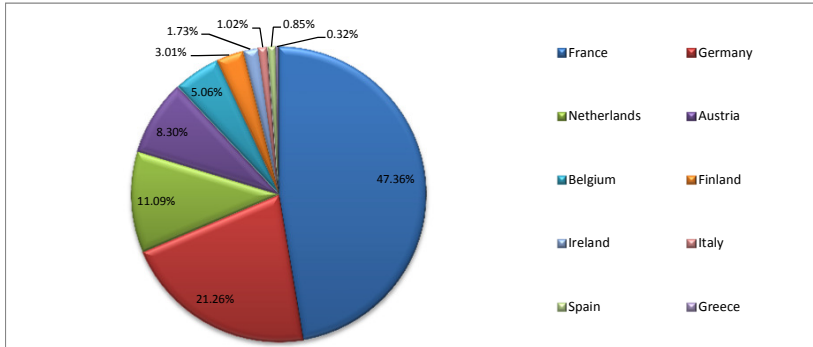
Product Description

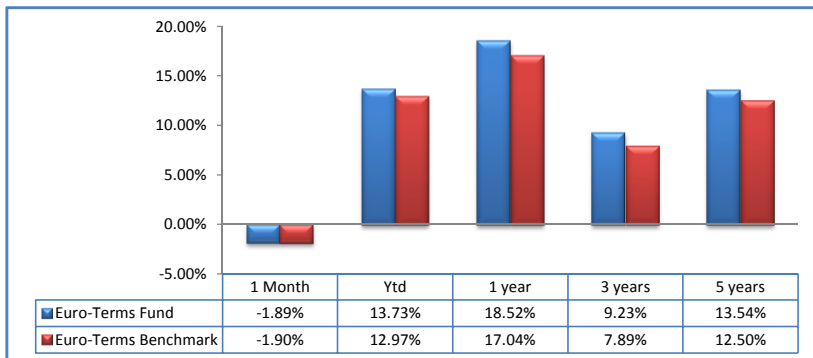
Sector Allocation
