



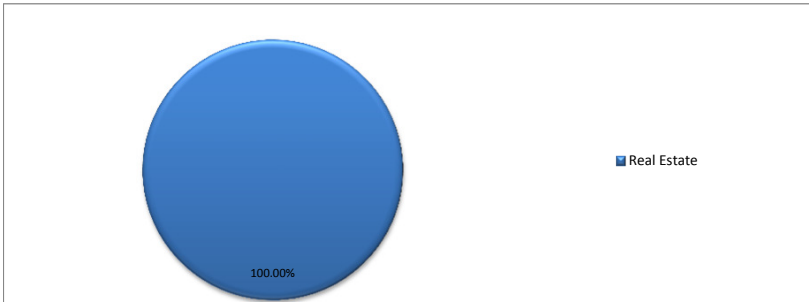

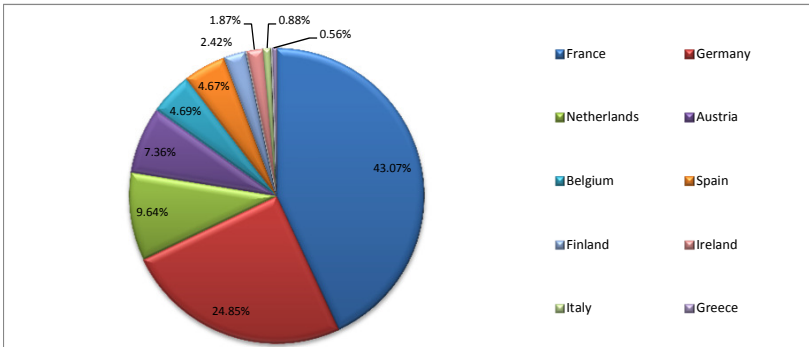

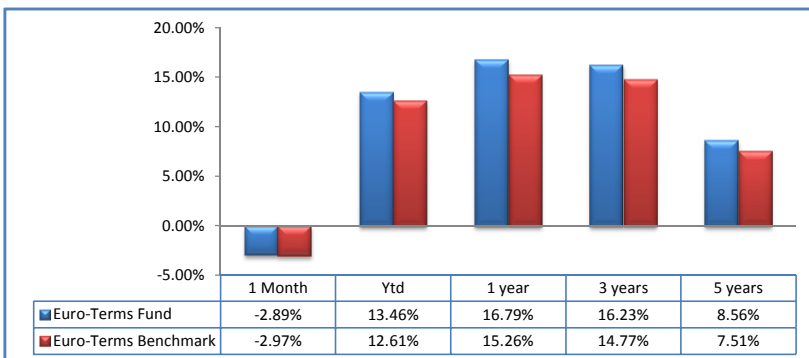
Sector Allocation
