



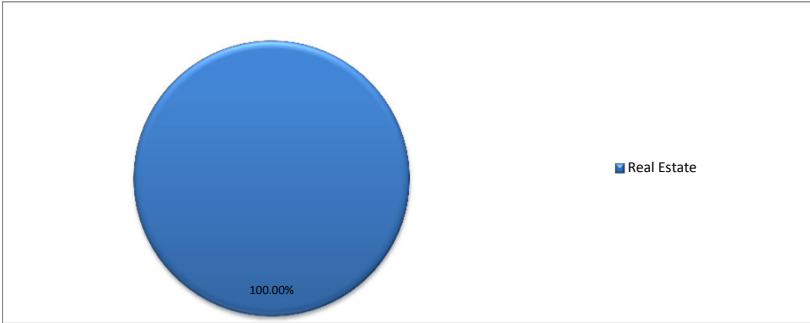

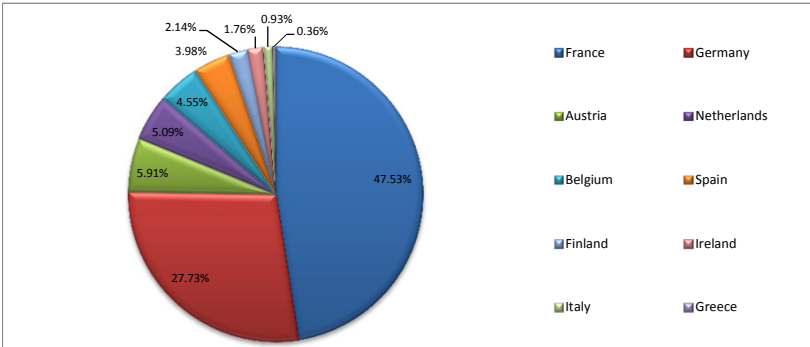

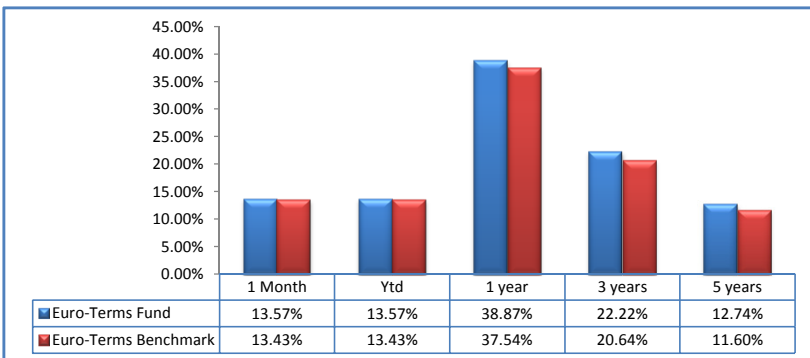
Sector Allocation
