

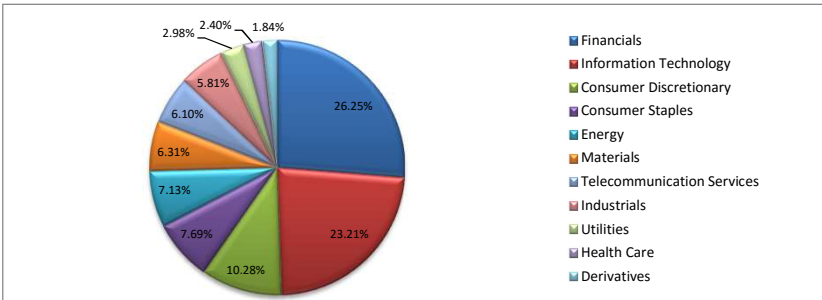

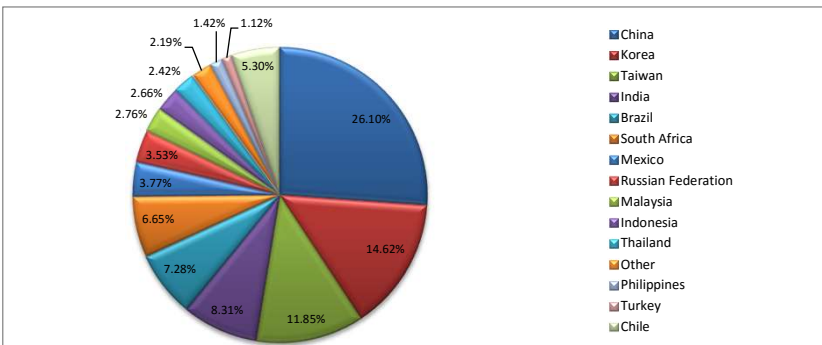
Product Description

The Index seeks to provide a return on investment that tracks, as consistently as possible, international equity markets, as measured by the MSCI Emerging Markets index.

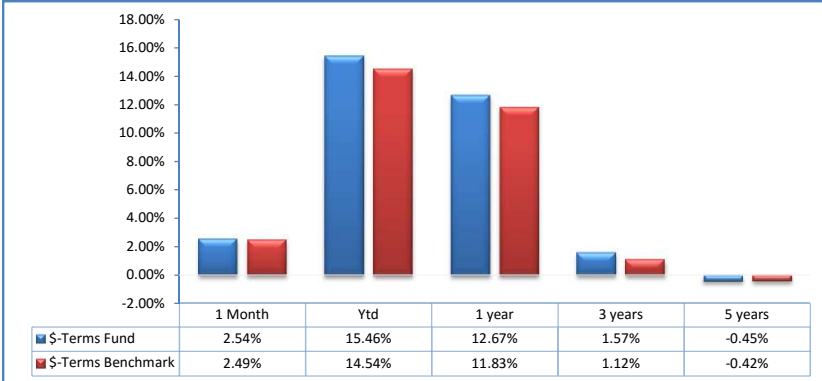
Sector Allocation

Presently there is a maximum of 20bps custody, audit fee etc. This custody fee of a maximum of 20bps is already taken into account in the gross returns of these funds.

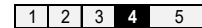
