

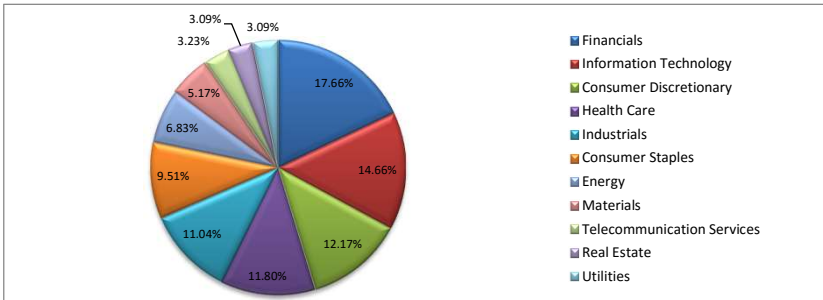

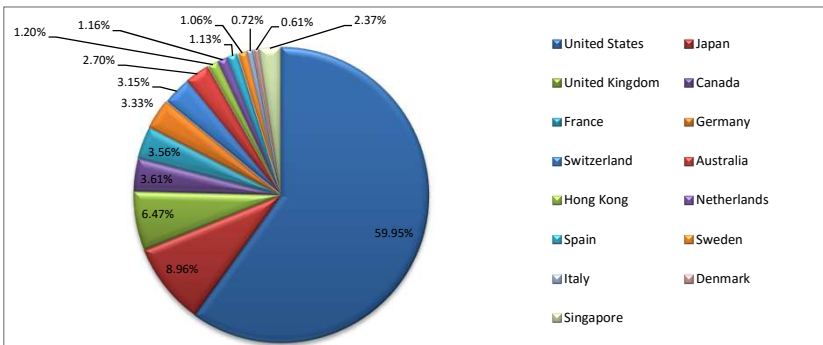
Product Description

The Index seeks to provide a return on investment that tracks, as consistently as possible, international equity markets, as measured by the MSCI World index with dividends reinvested.

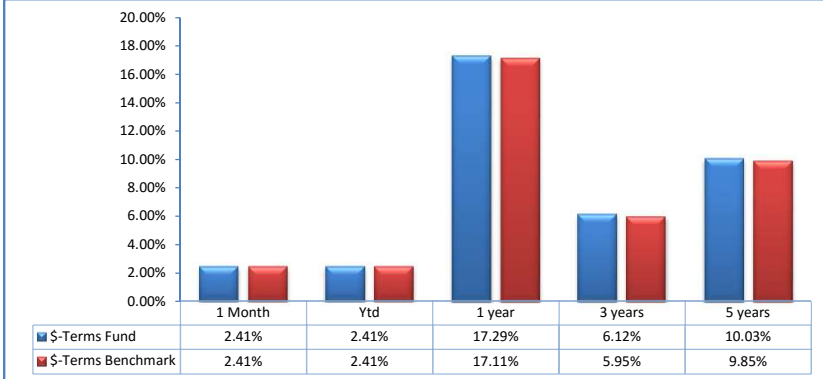
Sector Allocation

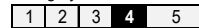

Highlights: The Total Expense Ratio (TER) for this class of portfolio is indicated on the website www.ginsglobal.com. Presently there is a maximum of 10bps custody, audit fee etc. This custody fee of a maximum of 10bps is already taken into account in the gross returns of these funds.
