

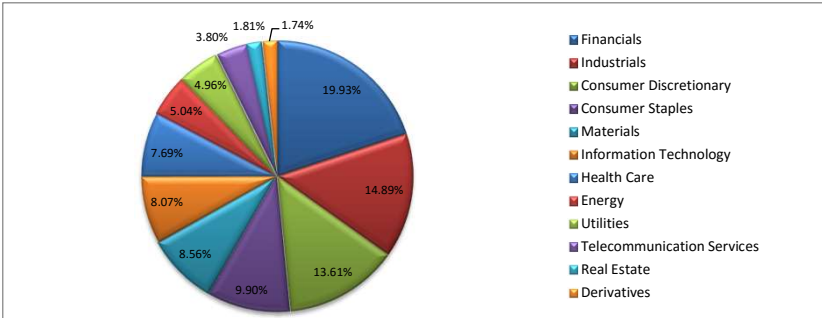

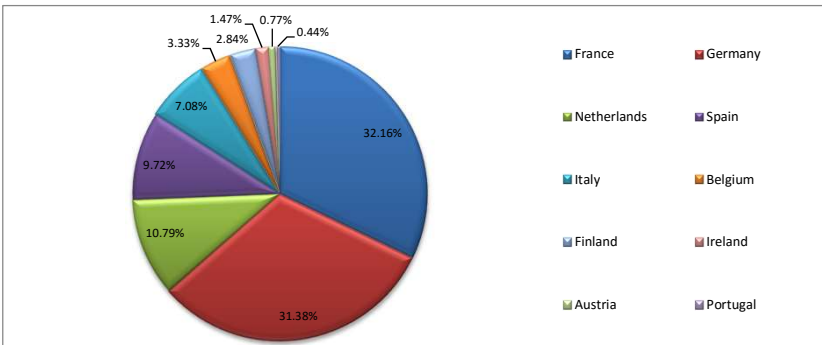
## Product Description

The Index seeks to provide a return on investment that tracks, as consistently as possible, Euro zone equity markets, as measured by the MSCI EMU index.

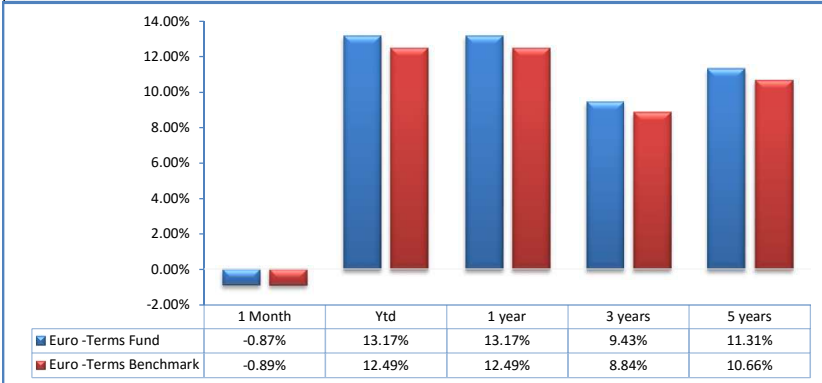
## Sector Allocation

Forward pricing is used and funds are valued on a daily basis by no later than 17h00. Figures quoted are from GinsGlobal Index Funds using NAV-NAV prices, with income and dividend distributions reinvested in the Portfolio. Performance is quoted in US dollars or Euro terms, depending on the denomination of the Fund. Fluctuations or movements in exchange rates may cause the value of underlying international investments to go up or down.
