

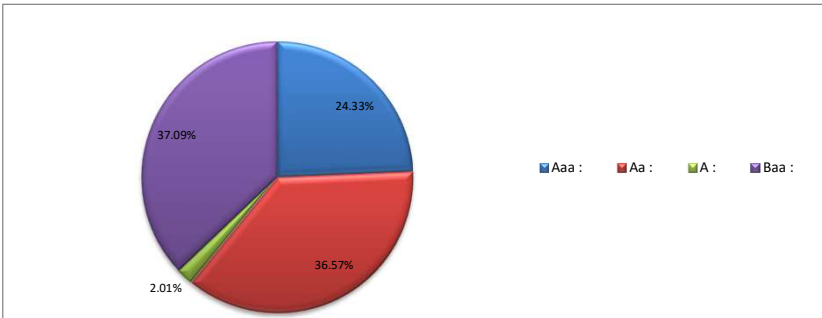

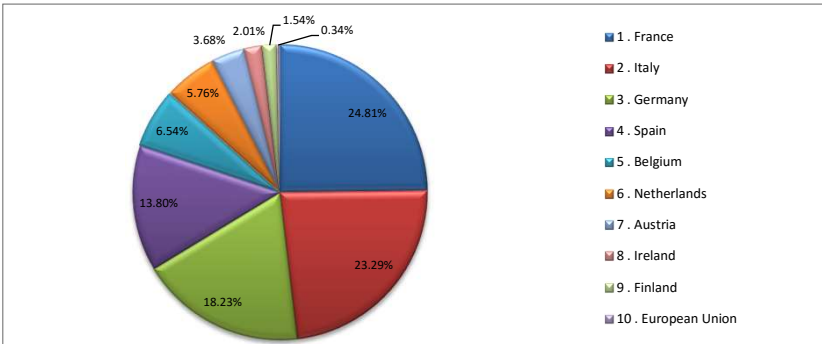
**Product Description**

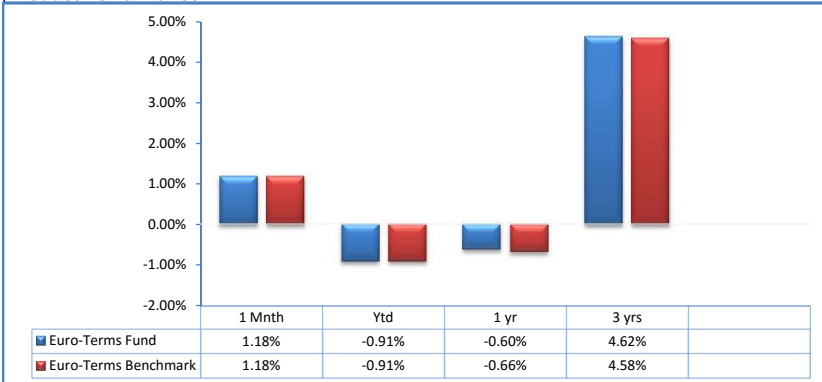
