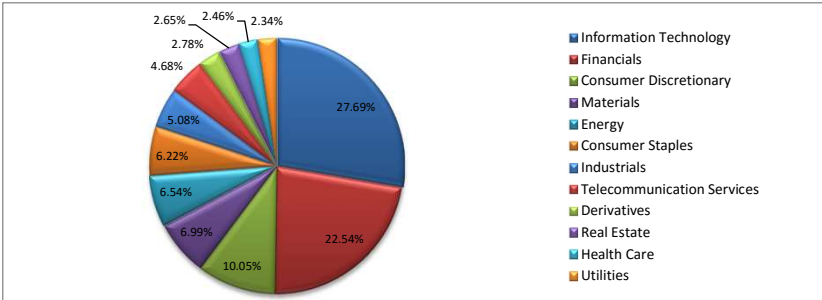

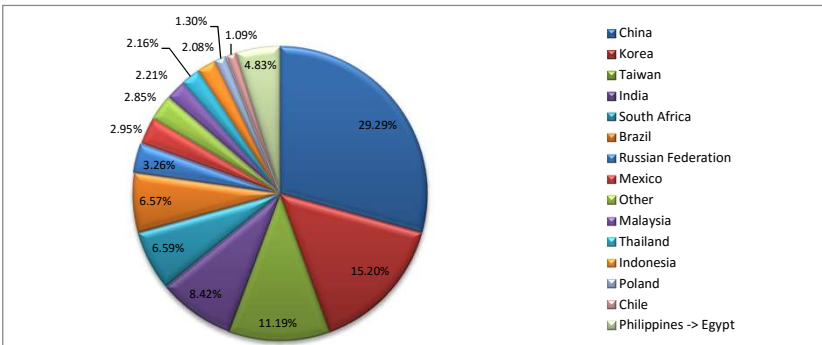
**Product Description**

The Index seeks to provide a return on investment that tracks, as consistently as possible, international equity markets, as measured by the MSCI Emerging Markets index.

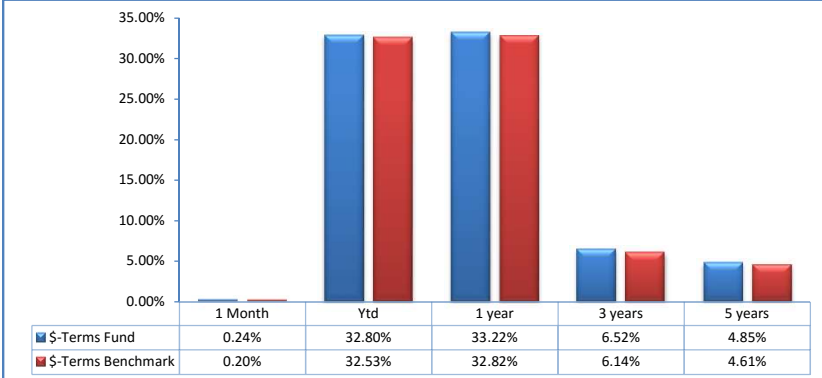
**Sector Allocation**

Permissible charges include: STT, auditors fees, bank charges, trustees/custodian fees and the service charge levied by GinsGlobal ("the Manager"). Currently these permissible charges costs add to the TER of the portfolio. Where anti-dilution entrance and exit levies are applicable to the portfolio, these are levied against the participatory interests of the investor prior to investment and redemption. The portfolios are traded at ruling prices and can not engage in borrowing and scrip lending. A schedule of all fees and charges and maximum commissions is available on request from the Manager. Commission and incentives may be paid and if so, would be included in the overall costs.

Forward pricing is used and funds are valued on a daily basis by no later than 17h00. Figures are quoted on a daily basis from GinsGlobal Index Funds using NAV-NAV prices, with income and dividend distributions reinvested in the Portfolio. Performance is quoted in US dollars or Euro terms, depending on the denomination of the Fund. Fluctuations or movements in exchange rates may cause the value of underlying international investments to go up or down. Presently there is a maximum of 20bps custody, admin and audit fee on this fund. This fee is not taken into account in the gross returns of these funds.

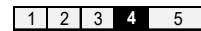
