

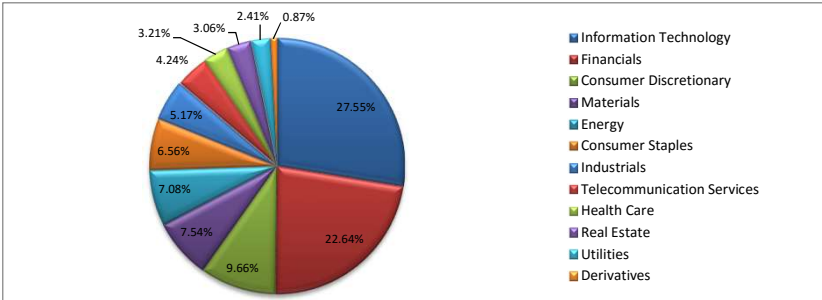

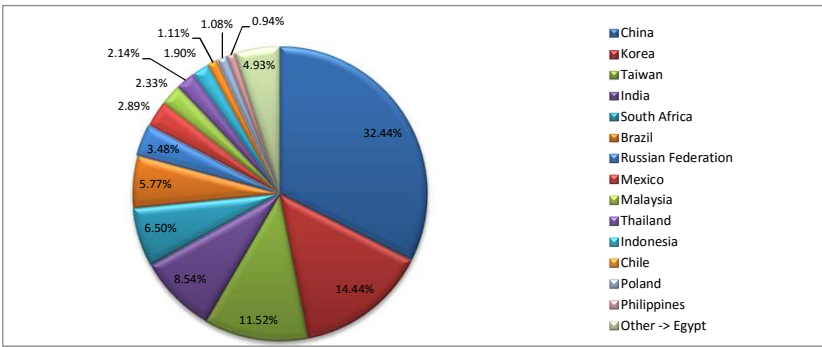
## Product Description

The Index seeks to provide a return on investment that tracks, as consistently as possible, international equity markets, as measured by the MSCI Emerging Markets index.

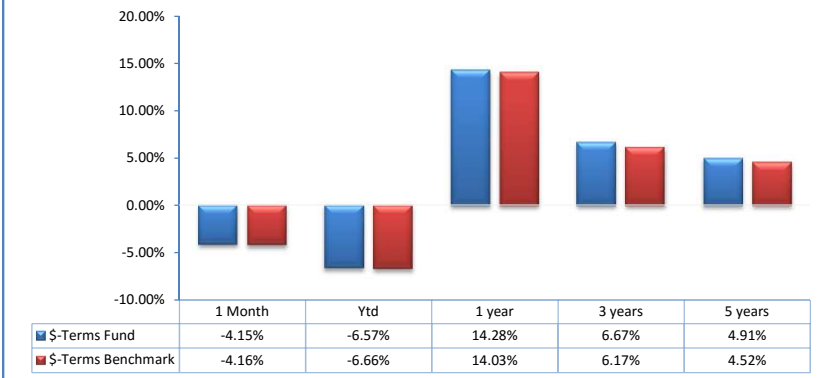
## Sector Allocation

Forward pricing is used and funds are valued on a daily basis by no later than 17h00. Performance is quoted in US dollars or Euro terms, depending on the denomination of the Fund. Presently there is a maximum of 20bps custody, admin and audit fee on this fund. This fee is not taken into account in the gross returns of these funds.

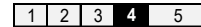
