

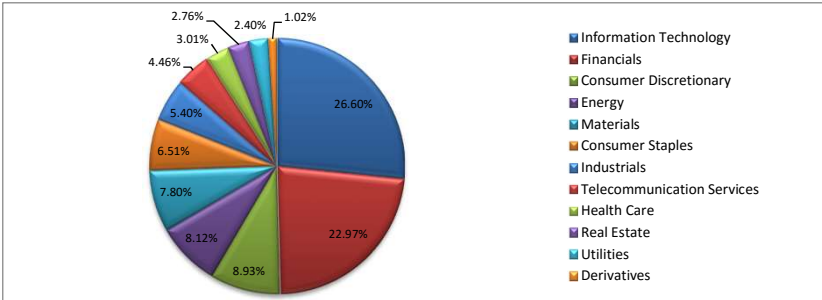

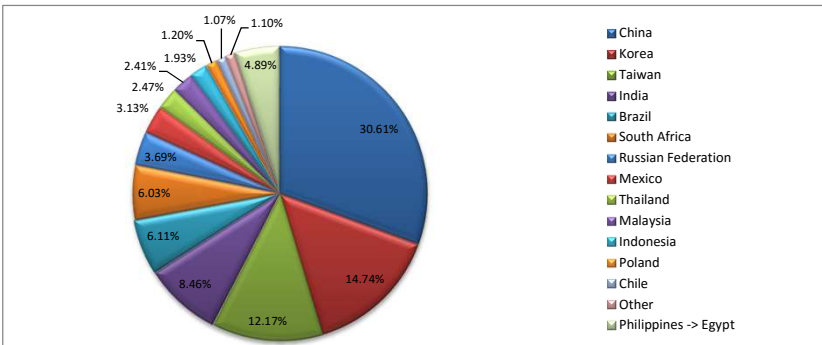
**Product Description**

The Index seeks to provide a return on investment that tracks, as consistently as possible, international equity markets, as measured by the MSCI Emerging Markets index.

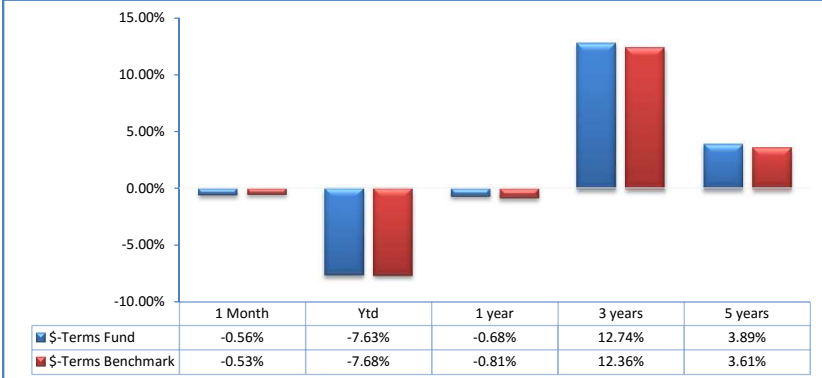
**Sector Allocation**
